Please Note:

- > To apply for an Iranian visa you must send in your passport along with a money order, address form, and "Visa Grant Notice/Visa Submission Notice" obtained through E-Visa website.
- ➤ Citizens of countries who are listed in the <u>E-Visa</u> website must apply directly at the Iranian Interests Section in Washington DC. Please follow the visa procedure as stated below.
- ➤ Other applicants should either apply via their host in Iran or through travel agencies.
- > Iranian women who tend to apply for their non-Iranian spouse or children, whose country of residence is not listed:
 - a. for children (under the age of 18) should fill in the attached form and send it in along with the required documents.
 - b. for their spouse or children above the age of 18 should have their family members in Iran submit their application through the visa office in the Ministry of Foreign Affairs.
- ➤ If you are applying via your host in Iran or through travel agencies, you need to send in your "Visa Grant Notice" along with your passport and money order.
- Family" category applies only to the spouse and children of Iranian women whose marriage is registered within the Iranian legal system.
- Money orders should be in US dollars and made payable to the "Embassy of Pakistan". (To facilitate the process for Canada residents, obtain money orders from the post offices)
- > We do NOT accept pre-paid return envelopes. Therefore, please add \$40 postage fee to the visa fee before you obtain a money order.
- Each package should include the documents of parents and/or their children ONLY.
- > Travel agencies can send up to **5 passports only** per package.

Visa Procedure

To apply for an Iranian visa, the following steps need to be taken:

- 1. Visit http://e visa.mfa.ir
- 2. In the section titled "Individuals and Travelers", click on "Apply Now"
- 3. On the right side of the page, carefully review "Important; Before You Start" section
- 4. Click on "Start a Visa Application"
- 5. In the "Visa Type", you can choose "<u>Tourist</u>", "<u>Pilgrimage</u>", or "<u>Family</u>". If you need to apply for other types of visa, your travel agency should apply for it on your behalf.
- 6. Follow the steps to complete the application
- 7. When finished, "Visa Application Submission Notice" will appear on your screen
- 8. Print it and send it along with your passport and money order to the Interests Section of Iran in Washington, DC. We will notify you if further steps may be required.
